RRECS when every day feels like mail count....

With the new era

of rural carrier compensation starting this spring comes many changes. The Rural Route Evaluated Compensation System (RRECS) is over 10 years in the making. Gone are the days of a few week count once every couple of years. Now rural carriers will be compensated based in part from:

- * rolling 52 weeks of data/volumes
- * 4 weeks of mini mail surveys a year
- * daily activity scans performed by the rural carriers
- * 47 different drive speed calculations based on how many feet are between each mailbox
- Distance from the mailbox to where a carrier parks to deliver a parcel to the door.
- Distance from the vehicle to the door where a carrier delivers a parcel that doesn't fit in a mailbox.
- * 181 total standards

And when I say data, I mean DATA.... Here is an example of the complexity of the formula used for one large parcel that the carrier has to drive 1000 feet from the mailbox to the park point near the door and walk 100 feet from the vehicle to the door.

- 30.9 seconds to handle, organize, mark and load the parcel onto the conveyance.
- 60.0 seconds drive time from the mailbox to the park point near the door.

- 51.4 seconds walking from the vehicle to the door.
- 51.1 seconds prelim & concluding at vehicle for trip to door.
- 12.3 seconds gather parcel from the vehicle.
- 11.7 seconds placing the parcel at the door, scanning the parcel.

TOTAL 217.4 seconds (3.62 minutes)

On a positive note, it will take just a few minutes daily to count each route for the mini mail survey which only makes up about 6% of the carrier's evaluation. Compensation for various office walk activities is .00429 a minute per foot. Random "raw" letters receive .0647 minutes a piece. Due to minimal time standards measured at the mini mail survey the expectation is that disagreements during the mini mail survey should be resolved at the local level.

I had hoped that with the implementation of RRECS it would lower the friction between managers and carriers but in many ways it has made it worse....now every day can feel much





like a mail count. Managers are now required to daily validate carrier activity scan entries which can make every day feel like count.

Often, carriers aren't making incorrect activity scans maliciously. Managers need to make sure all rural carriers along with any other craft delivering rural routes understand when to utilize daily activity scans.

As we do with other crafts spot check and observe. Review any anomalies. Actively supervise carriers when loading and during their afternoon duties which the get compensated actual time.

The minutes that a few carriers may try to manipulate a day is difficult to catch. And, for the few attempting to game the system most are honestly entering data. Others choose not to take the time to make the daily optional activity scans because of the minimal or no impact to their evaluation.

Many years ago I embraced a different mindset that has dramatically lowered the workroom floor temperature and my blood pressure. For the rural carrier that feels they are not getting paid enough and falsifies their route data, they have to live with themselves. Be kind to your rural carriers during these uncertain times for them.... trust but verify and keep calm and carry on!

Short Cuts Are Not The Solution

Richard Hui Adverse Action Member Representative Greetings Postmasters and Managers,

Our National Convention in St. Louis has come and gone. I was very happy to see so many of my friends in St. Louis. However, I also noticed that quite a few of the active Post-

masters and Managers carried a weary face behind their smiles. I believe the constant pressure of trying to be balancing between getting the mail delivered while short staffed, and getting their own administrative duties accomplished as managers is really taking a toll.

The Postmaster General, who was one of our Keynote speakers, mentioned that while he acknowledged the staffing shortages, which results with Postmasters and Managers forced to deliver mail consistently, but he warned that until the hiring and On-boarding process becomes satisfactory, the practice of Managers delivering mail practices must be continued, as the mail must be delivered.

Without getting into the compensation issues, cross crafting and grievances issues, let us concentrate on the problem at hand, how to get everything done in a workday.

Because of the staffing issues, Postmasters and Managers will have to go to work early to sort mail, cover lunches and to serve customers because of clerk staffing shortage. They will then have to go on the road and deliver mail to cover carrier shortages. By the time they return to their perspective office, they have already worked 10 hours or more. In addition, they still must accomplish their adminis-

Our National Convention in St. Louis trative duties, and often stay even later to try to get it all has come and gone. I was very hap- done.

Suffice to say, one can only do so much before physically or mentally breaking down. Under these conditions, striking a balance between work and family is almost impossible.

Unfortunately, this is when temptation arises, to just **Short Cut** duties and responsibilities and call it a day. Postmasters and Managers will get themselves in trouble, by completing checklists without really performing the check and balances. In fact, falsifying records can result in receiving suspensions, downgrade, or possible termination.

My advice to you is quite simple, when everything is a priority, then nothing is. If getting the mail delivered and servicing your customers is your number one priority, as your Postmaster General indicates, then that task must be taken as your priority. When you are running out of time to finish your administrative duties daily, you must inform your immediate manager, in writing, to inform him or her and explain why you cannot fulfill your duties and request assistance to allow you to perform your job in satisfactory manner. As usual, make yourself a hard copy and keep it in your personnel folder for future references.

Remember, striking a balance between your health, work and family is paramount. After all, your health and sanity is important and without your family's love and support, nothing else really matters.



2023......wow! I look forward to bringing you Bill's Buzz again this year. Thanks WI UPMA for giving me the space.

Speaking of a new year, did you notice a .30 cent a month increase for your dues as a retiree member of UPMA? Were you aware of this increase before it appeared on your annuity statement? I for one was very disturbed to find out the way I did, through the "grapevine", not from an official notification from UPMA. Very disappointing and I am afraid it will cost membership. I have heard from a number of retirees from around the county that are strongly considering dropping UPMA because of the way this was handled.

What Is Financial Wellbeing?

Financial wellbeing is how people feel about the control they have over their money. It's about achieving a sense of security, feeling that you are in charge of your day-to-day finances, and having enough money to make a choice about the life you live.

The two key aspects of financial wellbeing are having financial security, both now and in the future and understanding what makes you happy, and setting money goals to achieve that happiness.

Having a sense of control over your finances and being in a comfortable financial position means one thing less to worry about.

Identifying what makes you happy, and keeping this in mind, will help you improve your financial wellbeing over the long term.

Financial wellbeing isn't about how much money you have

FINANCIAL WELLBEING

I hope everyone took the time to review their FEHB and FEHVIP plans during open season. I know I did and sure am glad. If I had not done my research I would have missed out on a significant savings opportunity. The fact that we can use the "checkbook" free of charge and/or OPM comparison tools certainly makes things easier. So why do I bring this up after open season? It is so you put in on your calendar for the fall to review.

So that fits right into this editions article:

Financial wellbeing can be broken down into five core elements

Chris Budd, author of <u>The Financial</u> <u>Wellbeing Book – Creating Financial</u> <u>Peace of Mind</u> breaks things down in to five separate elements:

- 1. A clear path to achieve identifiable objectives
- 2. Control of daily finances
- 3. The ability to cope with financial shock
- 4. Financial options in life
- 5. Clarity and security for those we leave behind.

Let's look at them in turn.

A clear path to achieve identifiable objectives

Work out what makes you happy and how to achieve that happiness. People don't necessarily derive happiness from the amount of money they have to spend.

Research has shown that only 38% of people have considered in detail what (Continued on page 21) makes them happy or gives value to their life.

Wealthier people are more likely to think about what brings them joy and purpose

Happy people spend their lives doing two types of activity:

- Joyful activities things you enjoy doing or which you find relaxing. Playing a sport or eating out with friends
- Purposeful activities things that engage you or provide a useful purpose. Volunteering in the community, caring for others, or applying your DIY skills.

Joy = instant hits of happiness	Purpose = mean- ingful activities
Watching team sport	Volunteer work
Socialising with friends	Mending a broken shelf
Travelling	Raising children

Balance is important. If you know you spend more time on things that fall into the purpose camp, and not enough on the joyful stuff, consider how you could make a shift and rebalance to even things up.

Knowing your life goals and what you

want in the future can help you save for them and create a financial plan that invests in your future self and financial wellbeing.

Key takeaway

Lifestyle financial planning links the financial plan and investments with your personal ambitions.

Being the richest person in the graveyard is pointless, so we encourage you to enjoy the time you have on this earth.

For many of us, life consists of priorities, difficult choices and considered compromises. Our decisions often end up being a trade-off between several competing demands. Our job is about helping you consider the big issues in a way that helps you identify what matters most to you.

Control of daily finances

Know what you have coming in and going out. This covers the essentials like your mortgage or rent, bills and paying for food.

But setting aside money for the things that make you happy is important too.

An awareness of when and where you're spending can help you keep things under control. Being conscious of your income and outgoings can also help you identify areas where there's a potential to save.

40% of people have less than £100 to spend at the end of the month

No matter what income you have, people worry about money. Rather than always striving for "more", focus on what makes you happy over the long term. This positive mindset can help ease those worries.

Anthony Villis, Managing Director at First Wealth, has been a financial adviser for twenty-five years and knows from experience that money does not make you happy.

"I have worked with clients in the past with oodles of cash who are constantly downbeat and miserable and worry about every aspect of their lives," he says, "and I know many people who have very little in terms of financial assets but live incredibly joyful, happy and enriched lives."

Key takeaway

A lot of us fall into the trap of thinking that success will automatically result in happiness, or that they're the same thing. But it won't, and they're not.

Chasing success can be exhausting, frustrating and even detrimental to your health. And many ambitious people forget to keep in mind what success looks like, or even define it properly in the first place, and end up burnt out.

The ability to cope with a financial shock

Have an emergency rainy day fund, ideally a minimum of three to six months' income, in an easy-access savings account.

We've all experienced the shock of an unexpected bill. Something you didn't see coming, like a problem with your house that isn't covered by insurance. Or something you couldn't account for, like unexpectedly losing your job.

Having an emergency fund means you'll have something to fall back on. Simply knowing it's there will give you peace of mind.

Money isn't everything but struggling to meet everyday costs or to keep a bit saved 'just in case' can make us worry.

Even if you feel financially secure in all (Continued on page 22)

other regards, having a freedom fund gives you future options, and you'll probably sleep better too.

A third of people don't have a rainy day fund

<u>Research</u> shows that financial worries cause:

- Sleepless nights (26%)
- Anxiety (45%)
- Difficulty finishing everyday tasks (16%)

Relationship troubles (45%)

If you're among this group, start setting aside a bit of money each month. This single small act can improve your financial wellbeing and give you more freedom from worries.

Key takeaway

Write down your exact financial goal, for example, "I want to save six months' expenses in a separate easyaccess savings account by January 2023". Stick the note on your fridge or somewhere it will regularly remind you of your target.

This can help you stay on track to achieve it, especially if you add:

• A date so you can work out how much you can afford to save

• A fixed point you'll make the payment into your savings account

Automatic payments – set up a standing order to send the money to your savings account.

Take the boredom out of budgeting by combining it with something you enjoy. Listen to your favourite music as you work or combine it with a glass of wine or a cup of tea and an indulgent slice of cake.

Financial options in life

Another way to look at your emergency rainy day savings is to treat it as a freedom fund that will give you future options. This is a big part of achieving financial wellbeing.

Identifying what makes you happy leads to better financial wellbeing. Whether you dream of taking a career break, setting up your own business or enjoying an early retirement, the more money you save, the more flexibility you'll have, and the more options will be open to you.

Start saving as soon as possible. If you already have your emergency rainy day fund, start saving for your future aspirations. Your personal circumstances will dictate whether you save into a high-interest cash account or invest it. Think about the size of your goal, the timescale you have to get there and your appetite for risk.

Having a concrete picture of your life in the future can improve the financial decisions you make.

You just won't be able to stop yourself.

The average age of the military man is 19 years. He is a short haired, tight-muscled kid who, under normal circumstances is considered by society as half man, half boy. Not yet dry behind the ears, not old enough to buy a beer, but old enough to die for his country. He never really cared much for work and he would rather wax his own car than wash his father's, but he has never collected unemployment either.



He's a recent High School graduate; he was probably an average student, pursued some form of sport activities, drives a ten year old jalopy, and has a steady girlfriend that either broke up with him when he left, or swears to be waiting when he returns from half a world away. He has trouble spelling, thus letter writing is a pain for him, but he can field strip a rifle in 30 seconds and reassemble it in less time in the dark. He can recite to you the nomenclature of a machine gun or grenade launcher and use either one effectively if he must.

He digs foxholes and latrines and can apply first aid like a professional.

He can march until he is told to stop, or stop until he is told to march.

He obeys orders instantly and without hesitation, but he is not without spirit or individual dignity. He is self-sufficient. He has two sets of fatigues: he washes one and wears the other. He keeps his canteens full and his feet dry.

He sometimes forgets to brush his teeth, but never to clean his rifle. He can cook his own meals, mend his own clothes, and fix his own hurts.

If you're thirsty, he'll share his water with you; if you are hungry, his food. He'll even split his ammunition with you in the midst of battle when you run low.

He has learned to use his hands like weapons and weapons like they were his hands.

He can save your life - or take it because that is his job.

He will often do twice the work of a civilian, draw half the pay, and still find ironic humor in it all.

He has seen more suffering and death than he should have in his short lifetime.

He has wept in public and in private, for friends who have fallen in combat and is unashamed.



He feels every note of the National Anthem vibrate through his body while at rigid attention, while tempering the burning desire to' square-away' those around him who haven't bothered to stand, remove their hat, or even stop talking. In an odd twist, day in and day out, far from home, he defends their right to be disrespectful.

Just as did his Father, Grandfather, and Great-grandfather, he is paying the price for our freedom. Beardless or not, he is not a boy. He is the American Fighting Man that has kept this country free for over 200 years.

He has asked nothing in return, except our friendship and understanding.
