Happy Fall

Wow did summer fly by or what?!?!?

National Convention in Denver, Colorado was informative, relaxing, and a great place to visit. Once again we heard from Postmaster General, Louis DeJoy. He updated us on the Delivering for America Plan, what the Post Office has done so far, and the next steps we will be taking. USPS Ground Advantage, which reduces prices and simplifies shipping solutions, and improves service reliability, is well received by our customers. DeJoy updated us on the network consolidation, what has been done already and what's next. The regular price hikes on stamps and postage has helped to lesson projected losses due to elevated inflation. He updated us on where we are with USPS electric vehicles

and their charging stations. There is a lot of changes going on with the Postal Service. Hopefully these changes will bring us to a more stable future. More information on these topics can be found on the National UP-MA website under Legislative News.

H.R. 82 currently has 305 cosponsors, 211 Democrats and 94 Republicans. Right now, Congress is focusing on the budget and not on any legislative bills.

If H.R. 82 is not passed in the House and Senate, and then signed by the President before the end of the year, it will not become law. This means that if H.R. 82 is not passed, the current GPO and WEP provisions will remain in effect. All we can do at this point is hope Congress gets a budget in place



and avoids a government shutdown. Time will tell. Keep calling, texting, emailing or write a letter to keep H.R. 82 active in your Representatives mind.

PAC

John Douds, National PAC Chairman, announced that over \$23.500.00 was raised at the Denver National Convention. I believe this was the highest amount received at a National Convention in UPMA's history. Contributing to PAC can be done in three ways. Directly to UPMA using the PAC contribution card, current employees can use ePAC through Postal Ease as a payroll deduction. Retirees can contribute to ePAC through OPM. PostalEase Allotments to Postmasters and Managers Political Fund UPMA PAC

It's easy! Just use the established, confidential and secure *PostalEASE* telephone salary allotment system---or you may process your allotment on line. In this way, you are able to make a "direct deposit" from your paycheck to UPMA PAC. Each postmaster and manager currently has available for use **one "Net-to-Bank** "transaction (your payroll direct deposited to bank) **plus two additional allotments** through *PostalEASE*.

To authorize your allotment on line go to your website at www.liteblue.usps.gov. You will need your USPS employee ID number and PIN number.

- * Click on "PostalEase", "I agree", Enter employee ID and PIN again
- * Click on "Allotments/Payroll NTB", "Continue", choose "Allotments"
- * Enter Bank Routing Number (from worksheet below), enter account number (see worksheet), enter account type as "checking", enter amount of contribution.
- * Click "Validate", "Submit", "Print Page". Rec-

ord your confirmation number

OR: Call *PostalEASE* toll-free at 1-877-4PS-EASE (1-877-477-3273

- * When prompted, select *PostalEASE*, then enter PIN number

Know your ELM 651.2 Rights!

651.2 Representation

Subject to prohibitions regarding Executive and Administrative Schedule (EAS)/Craft representation, employees have free choice of representation. Representatives designated by employees, if postal employees and if otherwise in a duty status, are granted a reasonable amount of official time to respond to notices of proposed disciplinary action, to prepare for and represent the employee at a hearing held in accordance with 652.24, and/or to represent an employee who has appealed a letter of warning or emergency placement in a nonduty status in accordance with 652.4. Employees covered under these provisions may request representation during investigative questioning if the employee has a reasonable belief disciplinary action may ensue.

So what does this mean?!?

Whenever you are faced with a situation where you believe a conversation OR a situation could reasonably lead to disciplinary action, you are **ENTITLED** to a representative of **YOUR CHOICE**. Just because you are USPS management, it does not mean that your right to representation no longer applies. If you believe you may be in jeopardy of receiving any type of discipline or adverse action, you are entitled to a fair and just process.

5 U.S. Code § 7114 – Representation Rights and Duties, gives UPMA the right to assist our members when <u>YOU</u> request and choose our labor organization to represent you in a matter where you believe it could result in you receiving disciplinary action.

Now what does it mean that you have the right to a representative of your choice?

It means, any time that you are faced with a situation where you have a reasonable belief that the investigative questioning could lead to a disciplinary action (i.e. Emergency Placement, LOW, Suspension, or Notice of Removal), you may choose to be represented by UPMA, an attorney, or another representative. So you can literally ask a random stranger off the street to represent you if you really wanted to. Would we advise that? No, but I use this extreme example to show you that **you** control who you have

represent you, not the Postal Service. And yes, you always have a right to representation if your management is



going to conduct any type of investigation and you have reason to believe it could lead to discipline.

Now, with that, there are a few things you should know that are specific to choosing representation. First of all, you can only have one representative, so you need to be wise in choosing what is right for your situation. If you are unsure, contact UPMA and we will be happy to assess your situation and guide you to make the right choice for your situation. Just know that if you select UPMA as your representative, we will provide you with the best representation possible, and advise you when/if you may need more advanced representation. Also, once you are a member of UPMA for at least 1 full year, you are eligible for our Legal Defense Services if you receive adverse action that falls within the jurisdiction of the Merit Systems Protection Board (MSPB). The second thing you should know, if you do select UPMA as your representative, the President will select the UPMA Chapter Member Representative, but rest assured, all of our representatives are amazing and have a wealth of knowledge and we support each other to ensure your representation is top notch.

Representation should only be necessary when there is a behavior or action that violates USPS policies and procedures. While we truly hope you never need representation, we understand that with the increasing toxic environment (caused by staffing issues, the increased workload, impossible expectations, and generally a more stressful environment) it is becoming more and more necessary to defend our members for unfounded and often personal vendettas. UPMA wants you to know your rights of ELM 651.2. If you do find yourself in a situation someday, or you know of someone else that is in need of representation, **PLEASE**, **PLEASE** share the information on the inside cover of the Zip Line so we can assist. We welcome calls from ALL members whether you signed up 7 years ago or

UPMA wants you to feel heard and appreciated, because we all are human and we all expect the golden rule, to treat others as you would want to be treated...WITH DIGNITY AND RESPECT! UPMA is a firm believer that dignity and respect should always be maintained and honoring 5 U.S. Code § 7114 - Representation Rights and Duties is the Postal Services duty and your rights.

The OIG or Postal Inspection show up at your door! What should you do?

If you are questioned by the OIG or Postal Inspector about your conduct, even if you believe you are not guilty of any wrongdoing, it is suggested you do the following:

- ♦ Remain calm
- ♦ Correctly identify yourself if requested to do so
- ♦ Do not physically resist an arrest or a search of your person or property
- ◆ Read aloud to the OIG Inspector(s) the statement below
- ◆ Remain silent until you have consulted with your UPMA Representative or an attorney
- ♦ Be Your Own Protector Take No Lie Detector -
- ◆ Do Not Sign Get on the Phone

STATEMENT

If this interview is part of a criminal investigation, I request the presence of an attorney before any interview takes place. Until my attorney is present, I will not agree to sign any document or answer any questions. Furthermore, I will not make any written or oral statements. I do not consent to any search without a warrant. If you provide me with a search warrant, I will not resist the search while preserving my legal objections to it.

However, if this interview is not part of a criminal investigation, I request the opportunity to contact my UPMA representative for advice and to have them present during the interview. In such a case, I will be willing to orally answer questions but decline to provide any written statements. It is important to note that I retain my legal right to decline to answer any questions that could potentially incriminate me. I am committed to full cooperation, but I want to emphasize that I do not waive any of my rights, including the right to remain silent. I will not sign a waiver-of-rights form, admit or deny any allegations, or make any written or oral statements unless my attorney and/or UPMA representative is personally present to provide counsel.

Your manager informed you that they are doing a PDI or I&I. What should you do?

If at any point your manager instructs you to undergo a PDI or I&I, please remember that you have rights under ELM 650. You are entitled to choose a representative of your preference, and it's your prerogative to have your UPMA representative present during the investigation. In such circumstances, promptly get in touch with one of the UPMA Chapter Member Representatives. They will assist in coordinating with Postal management to schedule a suitable time for the interview where all necessary parties can be present to ensure a fair and just process.

Remember, remain silent until your UPMA Chapter Member Representative is present. If they ask any questions prior to your representative being present, answer all questions with "I am more than happy to answer any questions once my UPMA representative is present."







BY-LAWS OF THE WISCONSIN CHAPTER UPMA SCHOLARSHIP FOUNDATION

ARTICLE 1: NAME

The name of this corporation is The Wisconsin Chapter UPMA Scholarship Foundation. The term "Wisconsin UPMA Scholarship" shall stand for the full name of the organization.

ARTICLE 2: PURPOSE

Wisconsin UPMA Scholarship exists to award scholarships to children, step children, wards, grandchildren, and grand step children of members in good standing.

ARTICLE 3: STATUS

- A. Wisconsin UPMA Scholarship shall be a Non-Profit Organization and operated exclusively for the purpose specified in Article 2.
- B. Wisconsin UPMA Scholarship shall use its funds to accomplish the purpose specified in Article 2. No part of such funds shall be beneficial or distributed to a board member.

ARTICLE 4: BOARD OF DIRECTORS

THE Wisconsin UPMA Scholarship Board of Directors shall consist of the UPMA Wisconsin Chapter Executive Board President, Executive Vice President, Retiree President, Treasurer/ Secretary, and Scholarship Chairperson.

ARTICLE 5: GOVERNANCE

The Board shall direct and control the business management and affairs of Wisconsin UPMA Scholarship. They shall have the authority to approve or deny any requests for scholarships and to recommend dispensing of funds.

ARTICLE 6: SCHOLARSHIP FUNDS

The funds of the Wisconsin UPMA Scholarship shall be obtained primarily from donations, contributions from family members, friends, corporations, and the general public. All funds received must be unconditional.

ARTICLE 7: SCHOLARSHIP COMMITTEE

The Scholarship Committee shall be named in accordance with the provisions set forth in the Wisconsin UPMA governing documents and shall:

- consist of the Chair and any members appointed by the Chair to be on the committee.
- advertise for scholarship candidates in the "Zip Line" magazine, any special mailing, and on the Wisconsin UPMA website.
- make updates and changes to the application when needed, with the approval of the Wisconsin UPMA Board of Directors.
- screen applications judging on test scores, secondary school records, personal qualifications, community involvement, and such other criteria as approved by the Board of Directors. Decisions of the committee will be final.

ARTICLE 8: AWARDS

- A. The Board of Directors will decide annually on the number and amount of scholarships.
- B. Amounts awarded shall take into consideration the amount of money available for the number of applicant(s).
- C. Checks for each scholarship will be paid directly to individuals.

ARTICLE 9: APPLICATIONS

SECTION 1

- A. Completed application forms, together with all required enclosures, must reach the Scholarship Committee Chair no later than the advertised date each year.
- B. All applications received after the deadline will not be accepted.
- C. The application for scholarship must be completed in its entirety and shall include all required enclosures.

SECTION 2

- A. The scholarships are awarded for one (1) year.
- B. Scholarships are available for a high school graduate who is accepted as a first year student for fall admission to an accredited College, University, or Technical School.
- C. The method and schedule for processing applications will be determined by the Board of Directors.
- D. Successful applications will be announced at the annual UPMA Wisconsin Chapter Convention.

ARTICLE 10: SUCCESSOR CORPORATION OR DISSOLUTION

Should the Wisconsin UPMA Scholarship for any reason whatsoever surrender its charter, either voluntarily by action of the Board of Directors, or by action of state officials or a court of law, all of the property of Wisconsin UPMA Scholarship shall be turned over and delivered to the successor corporation, if a successor corporation has been duly formed. Otherwise, all property of the Wisconsin UPMA Scholarship shall be donated to a bona fide not-for-profit organization that is engaged in a similar work.

ARTICLE 11: AMENDMENT

The by-laws of Wisconsin Chapter UPMA Scholarship may be amended by a two-thirds majority vote of the Board of Directors at any regularly called meeting provided that prior notice of one (1) week has been given to all Board of Directors in writing.

What Scholarships are available? The members of UPMA Wisconsin Chapter will be sponsoring *TEN* \$1,000.00 scholarships for the 2023-2024 Academic Year.

Who is eligible to apply? An applicant must be a child, stepchild, ward, grandchild or step grandchild of a Dues-Paid Member, Dues-Paid Retired Member, or a Dues-Paid deceased Member's spouse of the UPMA Wisconsin Chapter.

AND all of the following:

** A High School Graduate of the current school year that is enrolled as a FIRST YEAR STUDENT for fall admission to an accredited College, University, or Technical School. The applicant must be maintaining a "C" grade average, be capable of pursuing further education and must be capable of providing means for his/her living expenses while attending school either from his/her own funds or reasonable assurance of earning same while in school.

What documentation must be submitted to apply for a Scholarship?

- 1. A completed UPMA Wisconsin Chapter Scholarship application signed by both the applicant and a parent. (Please use an additional sheet if space does not allow on the application).
- 2. On an additional sheet of paper, a biographical sketch outlining your background, your decision to pursue higher education and how you view your future once you complete your education.
- 3. A copy of the student's scholastic grades and attendance record.
- 4. A copy of the student's SAT and/or ACT scores if these exams were taken.
- 5. An endorsement letter from a responsible person not related to the student, who has had an opportunity to personally observe the student, and who can offer a worthwhile opinion of character, work ethic and other personal attributes.
- ** IMPORTANT NOTE: Please use a black pen or use the fill-in function for the online form www.wiupma.org
 Without the UPMA Wisconsin Chapter Scholarship application being fully completed and ALL of the documentation described above, your application cannot be thoroughly evaluated. An incomplete application packet will not be advanced to the judges. The missing documentation or a second application attempt will not be accepted after the application deadline.

How will the Scholarships be awarded? Each application will be judged individually, taking into consideration the factor of ability, proven performance, community involvement, the sincerity of purpose and the need of cultivation of the applicant's initiative and ambitions.

How are the Scholarship applications judged? There is a great deal of effort put into maintaining the integrity of the Scholarship Program. Judges from various areas of the state of Wisconsin, judge the submitted applications. Only the Scholarship Chairperson knows the Judges. These Judges cannot adjudicate the application of a relative. Once all applications are received and recorded as a complete application, by the Chairperson, they are sent on to the Judges for review. Once the applications have been circulated through all of the judges, the ballots are tabulated; the Scholarship Chairperson verifies the ballot results and begins the notification process.

After a Scholarship is awarded, how does the recipient go about receiving the payment? The UPMA Wisconsin Chapter Scholarships are paid in two equal payment of \$500 each. The recipient must submit proof of enrollment for Fall admission to an accredited College, University, or Technical College to the Scholarship Chairperson. Because students can be accepted to several colleges, a copy of the enrollment letter or email, from the College, University or Technical College showing the classes enrolled is required documentation. If by email, the email must be printed, signed and dated by the student and mailed, hard copy, to the Scholarship Chairperson. Again, it is the enrollment, not acceptance, information that is required.

To receive the second \$500 payment: the recipient must provide their passing grades transcript from their first semester. This also needs to be printed, signed and mailed, hard copy, to the Scholarship Chairperson.

This came across my computer form Charlie Wells from Atkins Ar. I feel it's something that can be beneficial to us all. This has been checked by a Trust Attorney and I had Bill Tierney look it over, both said it's good idea to do this. The link below was provided by Bill and is an in depth guide to gathering and recording information needed upon your death. I added the \$100 dollar bill to get your attention to this article.

- 1. Make sure all of your bank accounts, retirement accounts, etc..., have direct beneficiaries.
- 2. TOD-Transfer on Death deed for your home and/or other properties. Some states call this a beneficiary deed. It must be filed at the courthouse. This allows you your home ownership to be transferred to your designee upon your death without going to probate. This can save your heirs thousands of dollars.
- A Living Will. This allows you to put in writing exactly what you want done in the event you cannot speak for yourself when it comes to healthcare decisions.
- Power of Attorney for Healthcare. This allows you to designate someone to make HEALTHCARE decisions for you if you are unable to make decisions yourself.
- 5. Durable Power of Attorney. This allows you to designate a person to make LEGAL decisions in the event you are no longer able to make them yourself.
- Last Will and Testament. This designates whom you wish your personal belongings to go too.
- 7. Funeral Planning Declaration. This allows you to say exactly your wishes as far a disposition of your body and what type of services you desire. I also suggest taking your children or whoever will be making decisions to the funeral home and pre-planning and pre-

- paying your funeral. This eliminates the questions of "what would they like done?" My kids didn't want to come with me but after some coercion they did and were glad that they were there.
- 8. Make a list of all account numbers. Banks, investments, credit cards, utilities ,OPM, etc...leave instructions as to how and when these need to be paid. Make sure your heirs know where life insurance policies are located and the contact numbers for the policies.
- Make sure you have ALL of your account passwords and logins available and can be found. Make sure someone knows where to find them when needed.
- 10. Make sure that you have titles for all of your vehicles and any deeds where they can be found. I have mine in a safety deposit box with my son as coowner. If you don't have a co-owner the bank is required in most places to lock up the box until a court appoints an executor of the estate.
- 11. VERY VERY IMPORTANT!!! Talk to the people closest to you and make all your wishes known. Talk to those you designated as well as those close to you that you didn't to explain why you did what you did. This helps people to understand your decisions and possibly avoid conflict between your heirs later.

Death Certificates!! It is much easier to order Death Certificates from the funeral home at time of death than later. Always order more certificates than you think you will need. You will need one for every bank, IRA, Life Insurance, etc...,that you have accounts with.

I would gather up all of this information and go talk to an attorney. Spending a few hundred dollars now will save your heirs thousands of dollars in the future. From personal experience I know that if this is done it can save months or years of time settling an estate. As older retirees this is not an easy subject to approach but it is something that we all should consider doing.

I hope this finds you all Happy, Healthy, and living life to the fullest extent possible.

This is the link Bill provided that will allow you to compete the information requested above and more. It looks like over kill and probably is for most of us. Take a couple of pages at a time and complete the information. Your heirs will be thank full you did. The form can be printed out, saved to your computer or filled out on line.

For me personally I don't want some bank, insurance company or trust, turning my inheritance over to the state because nobody knew about it, or how to make a claim for it.



Ok, as I mentioned earlier PSHB is coming. Here are some key things you want to keep in mind. In closing let me remind retirees of some ways you can stay informed:

- You must select a health insurance plan in PSHB during open season Nov 11-Dec 9 2024! Failure to do so will get you automatically enrolled in potentially a plan you don't want
- If you are an annuitant as of 1-1-2025 and have not previously enrolled in Medicare you ARE NOT REQUIRED TO. If you are an annuitant as of 1-1-2025 and have previously enrolled in Medicare you need to remain in Medicare to continue with PSHB coverage.
- If you are an annuitant entitled to Medicare Part A as of 1-1-2024 and did not enroll in Medicare Part B you and your eligible family members will have a special enrollment period to opt in. That period will begin April 1, 2024. Penalties will be waived. If you fall into this category you will receive a letter.
